 - a. Participating at their own risk and Rez Refuge is not liable injuries, theft, or monetary loss.

- b. Participants are expected to perform essential functions and/or interactions when participating in program activities and events. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions:
 - i. Common physical activities include walking, hiking, running, roller skating, fishing, and basic camping.
 - ii. Common community service activities include trash clean-up in public areas, trails, and neighborhoods; supply distribution to community members; graffiti removal and street murals; and elder home maintenance
 - iii. Common collaborative expectations are willing to learn and gain experience under/alongside the direction of Program Personnel; ability to work with many individuals and manage work relationships.
2. Participation requirements and regulations are meant to maintain safe conditions for each person involved, acknowledgement of each rule is required by the participant, please initial where shown:
 - a. ____ I will refrain from tobacco use while participating in Rez Refuge program activities, this includes having it in my possession. If tobacco products are found in my possession, I understand and acknowledge that Rez Refuge staff has the right to confiscate the tobacco products without the expectation of their return or reimbursement.
 - b. ____ I will refrain from drug use while participating in Rez Refuge program activities, this includes having drugs or drug paraphernalia in my possession. I understand and agree that if drugs and/or drug paraphernalia are found in my possession that they will be immediately confiscated, and either be destroyed or turned over to the proper authorities. I realize that confiscation of drugs or drug paraphernalia will not be reimbursed to me by Rez Refuge. I realize my parents will be notified if there is a breach in this portion of the contract.
 - c. ____ I will refrain from alcohol use while participating in Rez Refuge program activities, this includes having it in my possession. I understand and agree that if alcohol is found in my possession that it will be immediately confiscated by Rez Refuge staff and subsequently discarded. I understand that I will not be reimbursed for the loss of the alcohol. I realize my parents will be notified if there is a breach in this portion of the contract.
 - d. ____ I realize that participation in Rez Refuge program activities includes both female, male, and non-binary individuals and will respect all person's and their bodies.
 - e. ____ I agree not to bully, sexually harass, and/or otherwise harass staff or other participants while participating in Rez Refuge's program activities. I will respect others, their possessions, and property. I understand that malicious destruction of property could result in me being liable for replacement or repair.
 - f. ____ I agree to abide by all local, State and Federal Laws while participating in Rez Refuge program activities. I realize that failure to do so may lead to my arrest and/or imprisonment; as Rez Refuge is bound by local, State and Federal laws and regulations.
 - g. ____ I agree to participate in group activities and events. I realize that one of the primary goals of Rez Refuge outings and activities is to build teamwork, leadership, respect, and self-esteem so my participation is essential to my success and the success of others.

- h. ____ I agree that while participating in Rez Refuge program activities, I will adhere to the instructions of the Rez Refuge staff. I realize this is for the protection of the group and myself, this includes, but is not limited to participating in group activities and projects planned during an outing or program.
 - i. ____ I will refrain from the use of gang signs, language, or dress while on Rez Refuge outings and events. I will refrain from the promotion of gang lifestyles or behavior as well.
 - j. ____ I will not bring any type of weapon to Rez Refuge Ministries' property, programs, or outings. I acknowledge that firearms, knives, and clubs, as well as "fake" or pretend weapons are not permitted.
 - k. ____ I acknowledge that Rez Refuge Ministries can use photographs and video of me/my child in their organizational materials--such as brochures, newsletters, website, Facebook, and other promotional materials.
 - l. ____ I acknowledge that all immunizations records are up to date. (Please provide a copy of updated immunizations records.)
3. Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19
- a. *The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. Rez Refuge Ministries Inc ("the Organization") has put in place preventative measures to reduce the spread of COVID-19; however, the Organization cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending the Organization could increase your risk and your child(ren)'s risk of contracting COVID-19. Because Rez Refuge Community Center is open for use by other individuals, I recognize that I am at higher risk of possibly contracting COVID-19.*
 - b. *By signing this document your family voluntarily agrees to assume all of the foregoing risks and accept sole responsibility for any injury to the participant noted on this form, or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or the participant may experience or incur in connection with my their attendance at the Organization or participation in Organization programming ("Claims").*
 - c. *On my behalf, and on behalf of the participant, I hereby release, covenant not to sue, discharge, and hold harmless the Organization, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Organization, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Organization program.*
 - d. *I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that the participant and/or myself may be exposed and/or infected by COVID-19 by attending the*

Organization and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

- e. I understand that the risk of becoming exposed to or infected by COVID-19 at the Organization may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Organization employees, volunteers, and program participants and their families.*
